**Motion**, made by Supervisor Diana Edwards to adopt Local Law Enacting a Property Exemption for Volunteer Firefighters and Ambulance Workers Pursuant to Section 466-a of the Real Property Tax Laws.

Mark questioned Article #4 for exemption for the volunteers to get both if you're a fireman and EMT. Attorney Matt Fuller stated the volunteers get the better of the tow exemptions, not both.

**Resolution #2023-33** to reallocate \$20,000.00 from Highway budget DA9730.7 Interest Bond Anticipation to DA9950.9 Capital Reserve Project. Since we will not be moving forward with the culvert project on Sand Hill Road, we do not anticipate a securing bond in 2023.

**Resolution #2023-34** to reallocate \$5,000.00 from Highway budget DA9730.7 Interest/Bond Anticipation to DA9089.8 Employee Benefits to cover the costs of the new vision/dental plan.

**Resolution #2023-35** to reallocate \$8,000.00 from General Fund Contingent A1990.4 to Safety Inspection A3620.4 Contractual Expense. This is for interim Code Enforcement consulting services provided to us by Garry Robinson, P.E.

**Resolution #2023-36** to eliminate the hourly position of Cleaning Service for Town Hall and continue us8ing Buildings & Grounds employee to provide upkeep and cleaning of the Town Hall and Museum.

**Resolution #2023-37** to reallocate \$1,576.24 from Buildings A1620.1.1 Cleaning to Buildings A1620.1 Personal Services.

**Resolution #2023-38** to increase hourly pay for Building & Grounds/Recycle from the current pay rate of \$16.90 to \$18.00 an hour.

**Resolution #2023-39A** to increase hourly pay rate for Recycle Center attendant (works Saturday, Sunday and Wednesday) from current pay rate of \$16.77 to \$20.00 an hour.

**Resolution #2023-40A** to purchase new software program for the new Code Enforcement Officer. This is the Integrated Property System from Edmunds GovTech with a one-time fee for software package bundle and implementation in the amount of \$7,750.00 and yearly support services maintenance fee of \$3,000.00

**Motion**, made by Councilwoman Lorraine Newton to adopt all resolutions listed above (#2023-33 through #2023-40A), 2<sup>nd</sup> by Councilman Curt Schreiner.

**Public Input:**

Maureen questioned the recycling center that gets muddy this time of year and was wondering if anything can be done to fix the mud issue. Supervisor Diana Edwards said the funds are currently in the budget to repave this year. Superintendent Lehman Allen Jr stated that this summer 2023, the recycling center will be paved from the roadway entering Hadley Hill Rd to the recycling center, which will take care of the mud issue.

Superintendent Lehman Aleen Jr stated we received 3.6" of rain Wednesday April 5, 2023. Lehman was pleased with the crew who were able to get all washouts and roads passable by Thursday afternoon. John at the recycling center will be retiring April 30<sup>th</sup> after being with the town 13 years. Doug Dingman (currently the garbage truck driver) will be taking over the recycling center position. The general employees will rotate on covering the recycling center until a garbage truck driver takes over for Doug to be moved into the recycling center position.

**Motion**, made by Councilwomen Lorraine Newton, 2<sup>nd</sup> by Councilman George Lembo to adjourn the meeting at 8:16pm.
