Supervisor Mary Ann Johnson welcomed all in attendance and outlined the purpose of this Public Hearing. Supervisor Mary Ann Johnson introduced Comprehensive Plan Chairman Ted Mirczak and explained that he would be making a short video presentation.

Comprehensive Plan Chairman Ted Mirczak reviewed aspects of the Comprehensive Plan draft including the use of a slide presentation. Comprehensive Plan Chairman Ted Mirczak outlined what process the committee had taken to get to this point. This included regular committee meetings with a variety of guests who could give valuable information concerning various aspects of the plan. Copies of the draft have been submitted to the Adirondack Park Agency and to Saratoga County Planning. Surveys were sent out to landowners in the Town of Day with a response of 51%, and an in depth analysis of the responses was made and taken into consideration by the Comprehensive Plan Committee as the draft was being crafted.
