

SPECIAL MEETING - July 12, 2007 - DAY TOWN BOARD

A SPECIAL MEETING of the Town Board of the Town of Day, New York was held in the Town Hall on July 12, 2007.

The meeting was called to order by Supervisor Mary Ann Johnson at 6:05 PM and following answered roll call: - Town Council Neil Allen, Percy Allen, Suzanne Denn, Preston Allen, Town Clerk Carol Vaillancourt.

ASSESSOR INTERVIEW -

Supervisor Johnson called Mr. Loheide back for a second interview with the Town Board to review some of the issues from the first meeting and also so that current Assessor George Madison might also ask him some questions as he was not able to be present at the first interview.

DOG CONTROL OFFICER INTERVIEW -

Supervisor Johnson stated that she had spoken with Mr. Francis Allen previously regarding the Dog Control Officer position. Supervisor Johnson asked Mr. Allen if he had any animals, to which he replied that he does have a beagle, he also estimated that in the 18 years he has been married, he and his wife have had approx. 15 dogs. Mr. Allen did inquire whether or not this was strictly dog control, to which Supervisor Johnson replied that it was. Supervisor Johnson also pointed out that she wants someone who care about animals and who is also good at dealing with people. Supervisor Johnson asked the other members of the Board if they had any questions or comments. Councilwoman Suzanne Denn pointed out that whoever was hired should get the pre-rabies shots for their own protection, and that the Town would pay the expense.

Supervisor Johnson asked whether or not Mr. Allen could start immediately, to which he replied that he could.

Supervisor Johnson informed Mr. Allen that whoever was hired would have the use of the Town pick-up truck for performing his or her duties with the Town. Also, the Town had cages for the Dog Control Officer to use and that there was an extension at the Town Hall for the Dog Control Officer and that the messages could be picked up from the person's home. Mr. Ken Metzler, a former Dog Control Officer for the Town, would be available to work with the new Dog Control Officer and answer any questions that he could. Supervisor Johnson informed Mr. Allen that the salary for the job was \$3,400.00 to \$3,500.00 per year and that pay day was twice a month on the 15th day and the last day of the month.

Resolution #2007-28, made by Preston Allen, seconded by Suzanne Denn, to **hire Mr. Francis Allen** as the Dog Control Officer for the Town of Day, effective July 16, 2007.
