

SPECIAL TOWN BOARD MEETING OCTOBER 20, 2005

A Special meeting of the Town Board of the Town of Day, New York was held on October 20, 2005 at 6:00 P.M.

The meeting was called to order by Supervisor Johnson, the following answered roll call Town Council: Preston Allen, Neil Allen, Cheryl Allen, Percy Allen, Justice Charles Krom and Highway Superintendent Scott York

Full-time employees received a 5% salary increase and Part-time employees received a 4% increase all others received a 3 _%. The Highway Superintendent received a 3 _% increase because the town provides him with a truck and fuel. The increased cost of fuel was considered in this years percentage of increase

The Board began review of the 2006 Tentative Budget.

Town Justices A1110.4 Account was lowered from \$3,200.00 to \$2,500.00.

Assessor's A1355.1 Account was lowered to \$17,500.00 from \$18,630.00 for a new Assessor being hired January 1, 2006. \$4,368.00 was added for a Clerk for the Assessor

Health Officer A4010 .4 Account was lowered from \$775.00 to \$750.00.

Band Concerts A7270.4 Account in the amount of \$1,500.00 was added this year.

Historical Property A7520.4 Account was raised from \$2,000.00 to \$4,000.00 for any refurbishing needed to house the Justices in the Museum Building

Snow Removal DA5142.1 was raised \$1,037.00 to \$109,167.50 to cover an additional 350 hours.

State Retirement DA9010.8 reduced from \$25,000.00 to \$23,000.00

Hospital & Medical DA 9060.8 reduced from \$92,770.00 to 83,026.00

Resolution #2005-40 offered by Cheryl Allen, seconded by Preston Allen to adopt the 2006 Tentative Budget, with the changes made during this meeting, as the 2006 Preliminary Budget, setting **November 10th, 2005 at 7:00 P.M.** as the date and time for the public hearing on such Preliminary Budget. The Board further directs the Town Clerk to make five copies of the Preliminary Budget, and to prepare the required notices of such meeting. Ayes: Neil Allen, Cheryl Allen, Percy Allen, Preston Allen, Supervisor Johnson. **Carried 5-0**
