Liaison to the Hudson River – Black River Regulating District Dave Cox submitted a full report to the Board prior to the meeting. Dave Cox does report that at the May meeting of the Regulating Districts, they did approve the 5 county assessment for 07/22-06/23. There is a meeting tomorrow in Boonville. Seventy three tons of riprap was placed along the shore in the Town of Day. The water level is less than one foot below target for this time of year. There is no meeting in August. There is a meeting on September 13<sup>th</sup> at the Sacandaga Field Office.

Highway Superintendent Lehman Allen Jr. stated that he had a tele-conference with FEMA and DEC on June 29<sup>th</sup> regarding the culvert project on Sand Lake Road. The final design and cost estimate will be the next step. According to the DEC the span must be at least 25' due to flooding concerns and mitigation. A 25' span automatically makes this project fall under the category of a bridge. Our current engineer Garry Robinson is not qualified to do a 25' span. Mr. Robinson would like to add an associate to help with this project. The gentleman is from H & T Engineering. Highway Superintendent Lehman Allen, Jr. has asked Mr. Robinson to present his ideas and projected costs, including Mr. Tutunjain's fees to the Board before we go any further. Mr. Robinson will hopefully have a package put together for the next meeting.

Highway Superintendent Lehman Allen Jr. has been working on roadside mowing while the rest of his crew is doing road construction. Highway Superintendent Lehman Allen, Jr. thinks he will wait until September to do the Town's paving this year. He has heard that the price of asphalt might drop a little bit by then. The full time laborer on the Highway Dept. has moved on to another job and is no longer an employee of the Town of Day. The Highway Department is now two employees short. Luckily with help from our Supervisor and the Town Clerk we put an ad on Facebook with a great response. I was able to fill both positions, MEO and Laborer, with people who live in Town. I believe the numerous applications we received are directly related to the work or the Town Board, our previous Supervisor and our current Supervisor's work to upgrade our benefit package over the last two and a half years.

Councilman Curt Schreiner discussed AED training and CPR training also. Will do the sexual harassment training and violence in the workplace training at the same time. Councilman Curt Schreiner heads up the training each year.

Highway Superintendent Lehman Allen, Jr. mentioned chainsaw, work zone and chipper training which must be done in addition to the sexual harassment and violence in the workplace training each year.

Councilman George Lembo reached out to Saratoga County Emergency Services person Mr. Carl Zielman. Councilman George Lembo will continue to try and contact him.

Supervisor Diana Edwards announced that there will be Overdose awareness - NARCAN training at Day Town Hall on August 31<sup>st</sup>. Anyone in the community wishing to participate in this training can do so.

Councilman George Lembo mentioned active shooter training for Town Hall. Will try to get ahold of video. Mr. Carl Zielman feels we should be updated with training. Councilman George Lembo says that he will stay on top of this so training can be held.

#### **OLD BUSINESS -**

Supervisor Diana Edwards informed those present that all of the small ARPA projects have been done. The pickleball court is being used.

The museum is still being worked on, painting the exterior and interior.

Councilman George Lembo had a conference with Saratoga County Historian Lauren Roberts. Ms. Roberts gave him a lot of information.

Have a round table panel to have a discussion about working together to be on historical society. Maybe next year to help with the museum. Councilman George Lembo can be in charge to organize round table. Councilman George Lembo is working on getting a list of names. Charters that involve the Department of Education. Need inventory of items in museum. Councilman George Lembo wondered if Town Historian Dave Davidson could help with an inventory. Councilman George Lembo will talk to Historian Dave Davidson on Wednesday.

Recycling center brush – No one to handle brush or leaves. Haven't taken brush in two years.

Supervisor Diana Edwards suggests not taking brush this year, revisit the issue at the Organizational meeting.

Highway Superintendent Lehman Allen, Jr. stated that there is no good place to take it. The County won't accept it and Hiram Hollow no longer takes it. No place to take leaves.

Councilman George Lembo wishes we had some place to refer them to.

Highway Superintendent Lehman Allen Jr. explained that there is not money in the budget at present to build a pit to compost leaves.

Supervisor Diana Edwards suggests that perhaps residents can hire a landscaper to take care of brush and leaves on their property.
