Tax Map #42.11-2 Subdivision Variance

Chairman Ted Mirczak stated that the application for subdivision for Ottman/Cronk is still pending due to further investigation of the well/septic locations. Chairman Mirczak did talk with Code Enforcement Officer Ken Metzler to get clarification on where these could be located. He read from an email that he had sent to each member describing his conversation with Ken Metzler regarding the customary requirements for wells closer than 100' from a septic system. Chairman Mirczak asked the board members if they had any other questions before we declare this application complete.

Motion by Dick Traeger and seconded by Jack Vaillancourt to declare the application of Ottman/Cronk complete.

Chairman Mirczak explained to Mr. Ottman that the board would schedule a Public Hearing for the next meeting which will be on July 7th at 7 p.m. He also informed him that they would have to send certified mail to each neighbor within 500' to inform them of this. Mr. Ottman did not understand why this was necessary, as they had just done this for the Zoning Board. Chairman Mirczak explained that the Zoning Board and the Planning Board each deal with different issues, which causes the
