**A SPECIAL MEETING** of the Town Board of the Town of Day, County of Saratoga State of New York, was held in Day Town Hall, 1650 North Shore Rd Hadley NY 12835 on April 28, 2025.

The special meeting was called to order by Supervisor Harry Brennan at 7:00pm with the following roll call: Councilman George Lembo, Councilwoman Cheryl Allen, Councilman Danny Allen Jr., Councilman Joseph Flacke and Supervisor Harry Brennan.

Supervisor Harry Brennan explained that a general employee needs to be hired for buildings and grounds. The board agreed that this person will work Monday through Thursday from 7:00am-3:30pm part time for 32 hours a week at \$19.00 an hour. Councilman George Lembo stated this person will be directed by the Town Supervisor and the town board, the board agreed.

Councilman Joseph Flacke stated he can run a no cost or low-cost ad on indeed. The board agreed that the ad will go on indeed and the Town Clerk will wait to hear from the board if the ad needs to be posted in the Post Star as well.

Supervisor Harry Brennan said the general employee for buildings and grounds will work a couple days doing garbage, recycling, cleaning etc but is not guaranteed. Councilwoman Cheryl Allen said it doesn't have to be advertised like that, and it will be as directed and will be explained to the applicants. Councilman George Lembo wanted it clear on who the boss is and that it's at the discretion of the Supervisor and the town board no one else, Supervisor Harry Brennan agreed. Councilman George Lembo stated the buildings and grounds employee will be directly under the town Supervisor.

The board also agreed that the buildings and grounds employee will be interviewed by the board and will be directed by the Supervisor. Councilman George Lembo stated he wants to be clear that this employee will be directed by the Supervisor.

**Motion**, made by Councilman George Lembo to place an ad to hire a part time building and grounds employee at \$19.00 an hour for 32 hours a week from 7:00am-3:30pm Monday through Thursday, 2<sup>nd</sup> by Councilman Danny Allen Jr.
