A local law Relating to Prior Notice of Defects in Town Infrastructure
Be it enacted by the Town Board (Name of Legislative Body)

of Day as follows:
1. Definitions. As used in this local law, the term "Town Infrastructure" shall include and road, highway, carb, brilge, alley, lane, sidewalk, beach, dock or path which is the property of the Town of Day, whether located in a public read or right of way, park, parking area, public building or otherwise.
2. No civil action shall be maintained against the Town of Day for damage to property or injury to person in death sustained in consequence of any Town Infrastructure being out of repair, unsafe, dangerous or obstructed unless it appears that written notice of the defective, unsafe, dangerous or obstructed condition, was actually given to the Town Superintendent of Highways or any person or department authorized by such Superintendent to receive such notice, or where there was previous injury to person or property as a result of the existence of defective, unsafe, dangerous or obstructed condition, and written notice thereof was given to a department of the Town of Day, or here was written acknowledgement from the Town of Day of the defective, unsafe, dangerous or obstructed condition, and there was a failure or neglect within fifteen days after the receipt of such notice to repair or remove the defect, dinger or obstruction complained of, or the place otherwise made reasonably safe.
3. The Superintendent of Highways shall keep an indexed record of all written notices which the Town receives and acknowledgement of which the Town gives of the existence of such defective, unsafe, dangerous or obstructed conditions, which record shall state the date of receipt of each such notice, the nature and location of the condition state to exist and the name and address of the person from whom the notice is received. This record shall be a public record. The record of each notice shall be maintained in the Highway Department for a period of not less than
