Stamped Plans required by a NYS licensed architect for projects costing \$10,000.00 or more, and a NYS licensed engineer for projects costing \$20,000.00 or more.

**New Construction** Single Family Homes, additions, alterations: \$.16 sf, minimum fee \$100 **Garages** 1, 2, and 3 car: \$.16 sf, minimum fee \$100

Residential Storage Buildings, Sheds, and Pole Barns: \$.16 sf, minimum fee \$100

Decks: \$.16 sf minimum fee \$100

Commercial Storage Buildings: \$.16 sf, minimum fee \$200

New Commercial Construction: Renovations, Additions \$.24 sf, minimum fee \$200

Manufactured Home \$100.00

Manufactured Home in a park \$50.00

## Non-renewable permits

- Cell Towers/co-location ...... \$400
- Chimneys: Good for 1 yr. ......\$30
- Demolition Permit ..... no fee
- Fuel burning devices: Good for 1 yr. .....\$30 (including pellet, oil, wood stoves, fireplace & outdoor heating devices)
- Hunting Camp (no power or services): .....\$50
- Septic Systems or Repairs: Good for 1 yr. ...... \$100.00
- Swimming Pools: Good for 1 yr. .....\$30
- Water Wells: Permit required ..... no fee

Reports: Inspection Report: \$35.00; Written Determination: \$25.00; Municipal Search: \$25.00

**Non-profit organizations:** Permit required. No fee for grant work involving any non-structural work, i.e. new windows, doors, water heaters, etc.

**Note:** <u>Building without a permit or after the fact permits</u> will result in the fees being tripled. All fees must be paid before a permit can be issued. All permits expire 1 year from the month of issue. Permits may be renewed for \$50 a year up to two years. The renewal fee will then be 100% and a new application must be submitted. The Code Enforcement Officer may revoke or suspend permits at any time due to NYS Building Code or Zoning Law violations.

## PLANNING BOARD FEES

Site Plan Review: \$75 Subdivision Minor: \$75 per lot, 2 lot maximum Property Line Adjustment: \$75 Subdivision Major: \$500 for 3 lots, plus \$50 ea. additional lot

All fees for Subdivisions, Variances, Site Plan Review, and Property Line Adjustments are due upon application submission. These fees are non-refundable.
