**New Business:** Meeting tonight to discuss approval of Mr. O'Brien adjusting his boundary line. Mr. O'Brien explained that he would like to adjust a property line between two of his own adjoining properties. Mr. O'Brien reviewed the updated survey to show his proposed changes, he made a formal appearance before the Planning Board for a boundary line adjustment.

Chairman Mirczak talked with Atty. Meyer prior to the meeting and discussed if he saw any issues going forward with an adjustment. If the boundary line was moved Atty. Meyer agreed no impediments to the law, it is amending two non-conforming lots, but not making them nore non-conforming, actually it would be making one lot more conforming. It will not be creat ng a substandard lot so it will meet requirements.

Chairman Mirczak proceeded in reviewing the application, the brief description including reason for adjustment (page 3 of 4) was revised to include Mr O'Brien's explanation that the change was to give access to North Shore Road, thus giving tax parcel 42.9-1-8.2 access to the lake.

Chairman Mirczak said that the Planning Board needs to determine if Mr John O'Brien's Boundary Line Adjustment Application is now complete. All board members reviewed the application

Mr O"Brien agreed to change the SEQRA to add 2.4 acres to 3a, 0 to 3b, 2.4 acres to 3c. #4 check the Rural box. Chairman Mirczak questioned Mr O'Brien on missing information page 2, #12b and 13b both to be answered with No, #14 habitat is Forest.

Chairman Mirczak then reviewed and completed Part 2 Impact Assessment. All answers were checked no.
