Planning Board Chairman David Cox reports that the next meeting of the Hudson River Black River Regulating Board of Directors will be held March 13th. There is no meeting in February. Planning Board Chairman David Cox reports that he believes the Board is still two members short and the decision may be in the hands of the Governor at this time.

OLD BUSINESS -

The updated personnel manual for Town of Day employees has been distributed and Supervisor Mary Ann Johnson is waiting for the signature sheets, which acknowledge that an employee has received a manual, to be returned to her.

Supervisor Mary Ann Johnson reports that she is currently reviewing the medical insurance policy for Town employees regarding who is eligible, how much is to be paid by eligible employees, etc.

Discussion concerning the issue with the intersection of Walter Maxfield and North Shore Road were discussed with the owners of one of the properties on the corner of this intersection, the Town Board members, Supervisor Mary Ann Johnson, Attorney David Avigdor and Planning Board Chairman David Cox. Maps from surveyor Dave Barrass were distributed with updated information. Different options for handling this issue were discussed with Attorney David Avigdor pointing out that any plans will need approval from Saratoga County. Highway Superintendent Scott York will be briefed at a later date regarding discussion on this matter.

Regarding the cell tower on Horse Hill Road, Supervisor Mary Ann Johnson explained that final approval has been reached on February 02nd on both properties needed for the construction of the cell tower. Saratoga County has gone out to bid concerning emergency generator for tower, construction etc.

NEW BUSINESS -

Supervisor Mary Ann Johnson explained that Highway Superintendent Scott York had asked her about the need to build a garage to house the new commercial lawn mower and trailer when it was already being stored at the recycling center. The Board members agreed that if there is room to store the commercial mower and trailer at the recycling center than there is no need at present for a new building at the Town Hall.

Supervisor Mary Ann Johnson reports that the Town of Day has received approval regarding the Certificate of Need which enables the Town of Day to sign a contract with the Town of Corinth with regards to EMS services. Supervisor Mary Ann Johnson will
