Therefore that part of the Employee Handbook (section #803 page 84 Separation of Employment) is null and void until such time as the Town Board determines what the policy will be.

The Town Board has agreed to pay Frank Allen 30 days worth of sick days in a lump sum upon his retirement. This will be a one time non-precedence occurrence for this type of payment due to a misinterpretation of the 41-J plan when it was originally included in the manual. The Town of Day Town Board will be drafting a replacement to this section of the Employee Handbook.
