COMMITTEE REPORTS –

Interim Highway Superintendent Ronnie Ladd reports that this year's black topping has been completed. The highway crew is working on building up the sand pile by the highway garage and the mowing is almost done. The highway crew is also drawing more material for the shoulders of the roads.

Councilman Jeff Gray asked if the crawler has been fixed. Interim Highway Superintendent Ronnie Ladd explained that it has not been and that they are using the backhoe to push the sand. Supervisor Preston Allen has been talking to Interim Highway Superintendent Ronnie Ladd about renting equipment when needed.

Mr. David Cox, who is the liaison to the Hudson River-Black River Regulating District for the Town of Day, reminded the Day Town Board that the HR-BR Regulating District does not have a meeting in August and that their September meeting is the day after the next Regular Day Town Board meeting which will take place on September 08th, 2014.

Responding to Supervisor Preston Allen's question asking if Councilman Jeff Gray had anything to report, Councilman Jeff Gray replied no, all set.

Supervisor Preston Allen asked Interim Highway Superintendent Ronnie Ladd if the results from Rosick's Well Drilling testing of the Highway Garage's well water had been received yet. Interim Highway Superintendent Ronnie Ladd replied that the tests show nothing wrong with the well water, tested fine. Councilman Jeff Gray asked if it could have been because of the high water that there was a change in the well water. Interim Highway Superintendent Ronnie Ladd replied to the well water. so far and should be receiving others as the Town has multiple accounts with National Grid.

OLD BUSINESS –

Councilwoman April Schmick is working on the computer back up situation. Councilwoman April Schmick has spoken to Teri Edwards who works for Stored Technology, the computer tech company who monitors the Town of Day computers for problems and answers any computer questions or helps with computer problems that Town employees may have. They discussed a server, the replacement of Windows XP which is on some of the computers, any computer with Windows 7 home would need to be upgraded to Professional, storing data off site etc. Councilwoman April Schmick stated that a grant may be possible to help finance the upgrades, changes etc.

Supervisor Preston Allen is working with someone else at Verizon to get the cell phone booster in place.

Councilman Curt Schreiner asked Supervisor Preston Allen for the amount of money the Town of Day has been credited with so far with the new newspaper etc. recycling company Green Fibers. Supervisor Preston Allen replied that the Town has earned \$75.00 so far.

Supervisor Preston Allen has suggested the Town purchase a plaque to present at the Deceased Veteran Ceremony on Sept. 16th in Ballston Spa. Councilman Jeff Gray offered to check on name of company who does plaques.

NEW BUSINESS –
