Hudson River – Black River Regulating District liaison David Cox reports that the last meeting was December 10^{th} in Watertown. The court awarded 4-5 million dollars from five counties to be paid to the Hudson River – Black River Regulating District. FERC has told Black River – Hudson River Regulating District that they need to provide a system for warning residents of a problem.
