WHEREAS, the Town Board of the Town of Day, County of Saratoga, State of New York, wishes to honor the memory of SAMUEL W. "SAM" JOHNSON as our Saratoga County deceased Veteran of the Month at the March 20, 2018 ceremony to be held in Ballston Spa NY, and;

WHEREAS, SAMUEL W. JOHNSON was born May 10, 1945 in Glens Falls, NY, and graduated from Hadley-Luzerne Central School in 1964 and;

WHEREAS, SAMUEL W. JOHNSON entered the US Air Force in 1964 and completed training courses in Survival Training, Special Air Warfare, Weapons Maintenance Supervision and Weapons Mechanic Training before being sent to Vietnam, where he was stationed at Bien Hoa and served as a gunner on a AC-47 Spooky gunship, aka "Puff the Magic Dragon" for over 300 night missions including during the TET offensive, and;

WHEREAS, SAMUEL W. JOHNSON was awarded the National Defense Service Medal, Vietnam Service Medal, Republic of Vietnam Campaign Medal, Republic of Vietnam Gallantry Cross with Palm, Air Force Good Conduct Medal, Air Medal, Small Arms Expert Marksmanship Ribbon, and;

WHEREAS, SAMUEL W. JOHNSON upon his discharge from military service on September 17, 1968 at the rank of Staff Sergeant, was employed as a Lineman and Line Foreman by Niagara Mohawk for 31 years, served as Town Councilman, Board of Assessment Review member, on the Cemetery Committee and as Town of Day Republican Committee Chair, and;

WHEREAS, SAMUEL W. JOHNSON was an avid hunter and fisherman, and was a 53 year member of the Hadley Hunting Club, he was also a member of VFW Post 5836 and Masonic Unity Lodge No. 22, therefore be it

PROCLAIMED, that the Town of Day remembers with pride the service of SAMUEL W. JOHNSON to his Country and to his Town and that the 20th day of March 2018, is hereby dedicated to the memory of SAMUEL W. JOHNSON.
