Liaison to the Hudson River – Black River Regulating District Dave cox reports that there was no HR-BR Reg. Dist. Board meeting in August. The next meeting is September 13<sup>th</sup> in Lowville. The training exercise did not take place on Sept. 08<sup>th</sup> at the dam. Was possibly moved to the Mayfield area. The water level for the lake is below the yearly average and 4 feet below the offer of settlement target. The next meeting is on October 10<sup>th</sup> at the Stillwater Reservoir office.

### **TOWN COMMITTEES -**

Councilman Jeff Gray stated that the Town of Hadley owns a mini back-hoe they use for ditching.

#### **OLD BUSINESS -**

The 200 year anniversary of the Town of Day and Digital Towpath will be discussed at a future meeting.

#### **NEW BUSINESS -**

Supervisor Preston Allen had a question for Attorney Matt fuller regarding paperwork for the grant that concerns the new highway truck purchased earlier in the year. Attorney Matt Fuller explained that both the Supervisor and the Highway Superintendent need to sign the paperwork.

Attorney Matt Fuller was asked by Supervisor Preston Allen about the difference between the Town abandoning a road and a discontinuance. Attorney Matt Fuller explained that when the Town abandons a road it ends the Towns obligation to maintain the road. Public can keep using it. A discontinuance ends everything. Doesn't take an official act like a resolution to abandon a road, but a discontinuance does need a resolution.

No date was set for the annual medical insurance review.

Supervisor Preston Allen informed those present that Saratoga County has been designated as a "Purple Heart County" for veterans.

Supervisor Preston Allen has spoken to Assemblyman Dan Stec. One company is talking about hooking up to local towers which would provide cell service with that carrier.
