Highway Superintendent Lehman Allen Jr. reports that the Town has received the final FEMA payment from the State.

The Town may be able to get \$11,998.00 from the State in relation to the same storm system that caused so much damage and the Town has already received FEMA money for.

Highway Superintendent Lehman Allen, Jr. would like to use some of that money to buy a hydraulic hose and crimping machine when the money comes from the State. Highway Superintendent Lehman Allen Jr. has reached out to two property owners regarding beaver dam control.

The highway crew is on putting a parking area in front of the cemetery located on Min Allen Road.

The Town of Corinth will be charging Towns who would like to use their paving machine and a couple of their workers \$1500.00 per day.

Liaison to the Hudson River – Black River Regulating District Dave Cox has submitted a complete report to the Board prior to the meeting. At the HR-BR Reg. Dist's. April 13th meeting two laborers were approved. The three year budget for the Reg. Dist. is being worked on. Possibly no permit increase, otherwise could go up 2%.

The Sacandaga Lake level at the end of April was 2 ½ feet below target. The level right now is on target.

Next meeting of the HR-BR Reg. Dist. is June 08th at 10:00am. It will be at the Sacandaga Field Office, 737 Bunker Hill Road, Mayfield NY.

Councilwoman Lorraine Newton has received the quarterly report for the first part of the year from the Corinth EMS. There were 21 calls to the Town of Day.

The cost to hook the server up to the highway garage would be \$1509.00.
